GLOBAL ADJUSTMENT		If you are paying HOEP/WAHSP or purchase electricity from a retailer, you will see a separate line item on your bill for Global Adjustment. The Global adjustment accounts for differences between the market price of electricity and the regulated or contract prices paid to generators for the electricity they produced. The Global adjustment also includes the cost of Ontario Power Authority conservation and demand management programs.				
		Global adjustment is calculated monthly by the IESO. It can be either a credit or a charge to consumers depending on fluctuations in the market price. (see www.ieso.ca)
