



Apprentice Powerline Technician(s) - 2nd Year & Higher Full-Time Employment

This position will be required to perform work across Niagara Peninsula Energy Inc.'s entire service area and may be required to work out of either the Niagara Falls or Smithville office.

Primary duties & responsibilities for this position include but are not limited to:

- Assist Lead Hand and/or Journeyperson Powerline Technician in maintenance and construction of overhead and underground power lines and equipment.
- Assist Lead Hand and/or Journeyperson Powerline Technician in stocking trucks and any other duties as required.

- Ensure the safety of co-workers and the public through proper use of safety equipment, and by following the rules, regulations, procedures and techniques in the Powerline Technician Training Manual, the Electrical Utility Safety Rules Book and other pertinent safety rules.

- Completion of the two (2) year post-secondary diploma in Powerline Technician.
- Working towards completion of Journeyperson/Powerline Technician Apprenticeship.
- Greater than one (1) year experience as an Apprentice Powerline Technician is an asset.
- Must have a valid "D" driver's license and a "Z" endorsement and be able to obtain an "A" or restricted "A" license.
